## TAG RETURNS IN 1986 - UNITED STATES HIGH SEAS SALMON TAGGING

This is a report of all recoveries of U.S.-U.S.S.R. high seas salmon tags returned between 1 October 1985 and 30 September 1986. There were six returns from releases in 1984 (1) and 1985 (5). Information on these tag returns is listed by year of recovery and release in Table 1. The 1985 recovery of a 1984 release (Tag J-671) marks a slight southern extension of the known range of southeast Alaskan and British Columbian immature sockeye salmon in waters west of  $180^{\circ}$  (previous record is  $51^{\circ}25'N$ ,  $177^{\circ}36'E$ ). The tagging experiments are summarized by Harris (1984, 1985).
